The New Schools

- Having recently announced 30 successful special free school applications, the DfE has now announced an additional 18 provisions through SEND wave 4 to meet need in the sector.
- 18 additional schools mean an investment of £105 million into SEND education.
- This a central free school programme; schools will be delivered and funded as such



Application Process

Application window closes 19th July Submit your completed Pre-registration window application by 11:59 pm 4 2 31st May 2024. by email to Application forms will be sent fs.applications@educat to you once you have ion.gov.uk. completed the preregistration. Autumn 2024 Application window Applications will be assessed opens 3 and interviews will begin 10th June Email fs.applications@education.gov.uk for an application form if you have not received one.

Spring 2025

Successful applicants will be announced, and the school will enter its preopening phase.

Local Provision

Stoke-on-Trent City Council (SOTCC) currently has:

- 4 Special Schools catering for various needs and 1 SEMH Free School opening in September 2024
- 3 SEN Units Communication & Interaction Needs (including Autism) – 70 pupils aged 3 to 7 years (KS1)
- A high level of high cost independent sector placements
- 2 Primary Resource Provisions approved for Speech Language and Communication Difficulty Needs catering for 48 pupils (24 places)



Need For The New Free School

- The new Free School needed for pupils with high levels of ASD need
- 66 pupils: 18 KS2, 18 KS3, 18 KS4 and 12 KS5
- Threshold of entry high levels of need
- New Local Banding Review for SOTCC Place Funding plus top up of up to £22,000 per pupil
- Centre of Excellence Model with outreach support and CPD role for other Stoke-on-Trent schools
- Local High Quality Stoke Provision for Stoke pupils





Although the official site is yet to be confirmed, it is normal at this stage for this to be the case The lack of a confirmed site should not impact the drafting of an application.

The Local Authority and the DfE are working hard to ensure suitable sites are identified, which can sometimes be a long process, however all parties are committed to delivering the free school within the timeline.

Financial viability

You must demonstrate that your school will be financially viable and sustainable. You must have robust and credible plans to attract good pupil numbers that take account of our minimum expected sizes for new free schools.

The financial template will be used to show income and planned expenditure, with reference to the assumptions the trust used and how these are realistic and appropriate.

At Create: Schools we have a variety of resources surrounding the financial template and free school funding, so please make sure to check our website for further guidance.



Writing a strong application

- Given the word counts, condensing information is essential. Be precise with language.
- Familiarise yourself with the HtAG and ensure the DfE criteria informs the structure of the application.
- All sections of your application must be consistent with your trust vision: ensure this is embedded within discussion of education, governance and finance.
- Discussion of the importance of community engagement and outreach further emphasises an awareness of the local context.
- Given the breadth of information covered in the application, allowing plenty of time for reviewing and redrafting is critical.



Writing a strong application

- Including case studies and specific examples ensures that claims are evidenced.
- It is likely that there will be multiple people who write the application, external review ensures that the application is consistent throughout and avoids repetition.
- Reviews through C:S come with thorough feedback, ensuring that all criteria is addressed within word count.
- Furthermore, the resources and guidance available on our website include further detail on what to include in the application and common mistakes to avoid.
